Over recent months we have seen a marked increase in interest and activity in the ESG space. Clients are increasingly approaching us seeking assistance with tracking ESG obligations and developments.

The increasing awareness of ESG appears to be a trend that is being replicated throughout Europe. Recently we were delighted to participate as the sole Irish representative in the inaugural meeting of the ESG Lawyers Network in Helsinki, a network of independent law firms throughout Europe with leading practices in the ESG space. It was a great opportunity to share experiences and opportunities from different jurisdictions with a group of exceptional, like-minded lawyers and hear presentations from industry bodies and clients that are providing leadership in these areas. Our overriding observation is that, while different ESG considerations are coming into focus at different rates in different jurisdictions, the direction of travel is common and we have a lot to learn from each other to best position ourselves to manage risk and identify opportunities.

In May we also participated in the 7<sup>th</sup> Biennial Energy Event hosted by the Energy Law Group in Paris. The Energy Law Group is a network of independent law firms with leading energy practices in Europe, the Middle East and Africa and Arthur Cox is the sole member for Ireland and Northern Ireland. Unsurprisingly, the energy transition was a very strong theme for the event with workshops on decarbonisation and hydrogen, as well as a very interesting examination of the rise of climate litigation (discussed further below). Again, this demonstrated the extent to which ESG considerations are becoming increasingly important to businesses and governments alike, a trend that is only going to continue.




